Book showing the ownership of minimum 3 Nos. of tankers, Work Contract Tax No./Certificate, Sales Tax Registration Number/Certificate, Payment of cost of Blank Tender Form as per Column No. 5 to be paid by Pay-Order/Demand Draft payable to 'MMRD Fund' of any nationalized or Schedule Bank payable at Mumbai.
 - b) Work completion certificate of similar nature of work amounting to 25 Lacs in the last 3 financial years.
 - c) Average annual turnover during the last 3 financial years shall be 100% of cost put to tender.
- 3) The intending tenders should also produce Solvency Certificate to the tune of 20% of the cost put to tender for the work.
