3. Bids will be received in the Office of the Chief Engineer, Engineering Division, MMRDA building, 5th floor, BKC, Mumbai-400 051, on or before 03/09/2013 up to 13.00Hrs & shall be opened on the same day after 15.00hrs (if possible).
4. Tender documents will not be sent or received by the post.
5. To qualify for award of the contract, each bidder in its name should have in the last five years i.e. 2008-09 to 2012-13
 - a) Achieved, in the five previous financial years, a minimum annual financial turnover (in all classes of civil engineering construction works only) of not less than the estimated cost put to tender.
 - b) Satisfactorily completed, one similar work (concrete road) of aggregate value not less than 80% of the estimated cost put to tender in Govt. / Semi Govt. organization.

The above requirements at (a) shall be certified by the Chartered Accountant and requirements at (b) shall be certified by the officer not below the rank of Executive Engineer.
