  - a) Valid Registration Certificate, Work Contract Tax No./Certificate, Sales Tax Registration Number/Certificate, Income tax certificate, etc.
  - b) Work completion certificate (Govt. or Semi Govt.) of similar nature of work amounting to 50% of estimated cost put to tender issued by the officer not below the rank of Executive Engineer in the recent last 3 financial years.
  - c) Average annual turnover during the recent last 3 financial years shall be 100% of cost put to tender.
  - d) The intending tenderers should also produce Solvency Certificate to the tune of 20% of the cost put to tender for the work.
- 4) Any type of influence during the process of tendering shall disqualify the tender from submission of his offer and further processing of his offer.
- 5) The offer shall remain valid for a period of 120 days from the date of opening of the tender.
