

DETAILED E-TENDER NOTICE (IInd Call) AND GUIDELINES FOR SUBMISSION OF TENDER

Digitally signed and unconditional online tenders (IInd call) on Lump-sum basis (Design-Build) are invited by the Chief Engineer, Mumbai Metropolitan Region Development Authority Bandra (East), Mumbai-400 051 for the following work from the experienced contractors who are registered in appropriate category with the Government of India / Maharashtra and its undertakings and those who have carried out similar type of works.

The tender documents can be downloaded from the above mentioned portal from 5th Sept. to 6th Oct, 2014. Pre-bid meeting will be held on 25th Sept, 2014 at 11:30 hrs in the office of the undersigned. The date of receipt of online bids is 10th Oct, 2014.

Bidders who are participating in e-tendering for the first time shall have to obtain digital ID & password from the abovementioned portal.

ELIGIBILITY : For award of work, the bidder should have achieved

- i) Average Annual financial turnover from Civil Engineering works during the last 3 years, ending 31st March of 2014 i.e. should be at least **Rs.3 Crore.**
- ii) Experience of having successfully completed similar works during **last 7 years ending last day of month previous to the month in which bids are invited** should be as follows.
 - a) One flyover work completed costing not less than the amount equal to Rs.3.50 Crore.
 - b) Construction of Flyover /Bridge /Viaduct work in Urban area using steel superstructure construction with at least one span equal to or more than 40 m.

Note:a)The weightage for updating of costs will be done @ 10% p.a. to arrive at 2013-14 prices. While updating costs in this manner, the total cost of completion only will be updated based on the year in which the work is completed.

iii) Bids from Joint Ventures are not allowed.

1. The bids will be received online on above mentioned MMRDA official E-Tendering portal and will be opened by the Chief Engineer on scheduled date and time.

4. Bidders who are participating in e-tendering for the first time shall have to obtain User ID & password from the above mentioned portal.

5. Bid Document and Supporting can be downloaded for reference purpose from the e-Tendering Portal of MMRDA during the period mentioned in the tender notice.

Interested Bidders have to make payment of Rs.25,000/- (Rupees Twenty-five Thousand only) inclusive of MVAT (non refundable) as Tender Fees by mode of Electronic transfer. The relevant details are as under:

6. The competent authority reserves the right to reject any or all of the tender offers, without assigning any reasons thereof.
7. The bids shall be received online on above mentioned MMRDA official E-Tendering portal.
8. Validity period of the offer of the tenderer will be 180 days from the date of opening of the financial bid of the e-tender.
9. The lowest bidder will have to submit the rate analysis of all major items, if called for.
10. Bidders should upload scanned attested photocopies of all documents on above mentioned MMRDA official E-Tendering portal & produce in original on request by MMRDA at any stage.
11. A statement showing names of partners, Directors, etc. of the firm with complete address of each should be uploaded to above mentioned MMRDA official E-Tendering portal and authorized person on the behalf of firm who will sign e-tender using digital signature certificate.
12. The acceptance of bid will be intimated by email or otherwise by the authority competent to accept the tender or by the higher Authority of MMRDA, to the contractor, which shall be deemed to be an intimation of the tender given by the Authority Competent to accept the tender.
13. Successful bidder shall have to submit signed copy of tender manually to the department.
14. MMRDA reserves the right to verify financial transaction of contractor in his Bank / Financial Institutions. Contractor should give authority to that effect along with his

accounts number and Bank/ Financial institution name & address. Any changes / modification may be communicated to MMRDA immediately.
