#### 1 Invitation for Proposal


- 1. MMRDA hereby invites Proposals for Supply, Installation and Commissioning of Computer Hardware, Software and Peripheral Solution at various MMRDA locations and Buy Back of out dated Hardware Inventory. Bidder/ Agencies are advised to study this RFP document carefully before submitting their proposals in response to the RFP Notice. Submission of a proposal in response to this notice shall be deemed to have been done after careful study and examination of this document with full understanding of its terms, conditions and implications.
- 2. The complete bidding document has been published on etendermmrda.maharashtra.gov.in for the purpose of downloading. The downloaded bidding document shall be considered valid for participation in the electronic bidding process (e-Tendering) subject to the submission of required tender/ bidding document fee and EMD.
- 3. Bidders who wish to participate in this bidding process must register on etendermmrda.maharashtra.gov.in
- 4. To participate in online bidding process, Bidders must procure a Digital Signature Certificate (Class II) as per Information Technology Act-2000 using which they can digitally sign and encrypt their electronic bids. Bidders can procure the same from any CCA approved certifying agency, i.e. TCS, Safecrypt, Ncode, etc. Bidders who already have a valid Digital Signature Certificate (DSC) need not procure a new DSC.
- 5. A three envelope selection procedure shall be adopted.
- Bidder (authorized signatory) shall submit their offer online in electronic formats for preliminary qualification, technical and financial proposal. However, tender document fees, and Earnest Money Deposit (EMD) should be deposited in the account details provided in the bid document.
- 7. MMRDA will not be responsible for delay in online submission due to any reason. For this, bidders are requested to upload the complete bid proposal well advance in time so as to avoid issues like slow speed, choking of web site due to heavy load or any other unforeseen problems.
- Bidders are also advised to refer "Bidders Manual Kit" available at etendermmrda.maharashtra.gov.in for further details about the e-tendering process.

#### 2 Instructions to Bidders

#### 2.1 Introduction of MMRDA

Mumbai Metropolitan Region Development Authority (MMRDA) is an apex body for planning and co-ordination of development activities in the Mumbai Metropolitan Region comprising Mumbai and its influence area and was set up under the Mumbai Metropolitan Region Development Authority Act, 1974 by the Government of Maharashtra.

The MMRDA prepares plans, formulates policies and programs, implements projects and helps in directing investments in the region. In particular, it conceives, promotes and monitors the key projects for developing new growth centers and brings about improvement in sectors like transport, housing, water supply and environment in the region.

#### 2.2 Purpose

The purpose of this RFP is to seek the services of reputed firm/agency, which shall supply, Install and commission the Computer Hardware, Software, Peripheral at various MMRDA Locations by procuring the necessary hardware & Software for the same and Buy back of the out dated hardware inventory. This document provides information to enable the bidders to understand the broad requirements to submit their bids. The detailed scope of work is provided in **Section three Page no. 18** of this RFP document.

#### 2.3 Cost of RFP

The qualified bidders are requested to deposit the Tender fees into the Bank account details mentioned below. The receipt of the same shall be uploaded during the online submission of bid document. Tender fee is non-refundable.

#### 2.4 Transfer of RFP

The RFP Document is not transferable to any other bidder. The bidder who purchases the document and submits shall be the same.

#### 2.5 Consortium and Joint Ventures

- The consortium, joint venture, subcontracting & outsourcing are not allowed.
- ii. One bid would be considered from one single bidder in case of multiple bid found from single bidder those bids shall be rejected and bidder may be disqualified from the Bidding process

#### 2.6 Completeness of Response

- i. Bidders are advised to study all instructions, forms, terms, requirements and other information in the RFP documents carefully. Submission of bid shall be deemed to have been done after careful study and examination of the RFP document with full understanding of its implications.
- ii. The response to this RFP should be full and complete in all respects. Failure to furnish all information required by the RFP document or submission of a proposal not substantially responsive to the RFP document in every respect will be at the Bidder's risk and may result in rejection of its Proposal and forfeiture of the Bid EMD.

#### 2.7 Proposal Preparation Costs

- i. The bidder shall submit the bid at its cost and, MMRDA shall not be held responsible for any cost incurred by the bidder. Submission of a bid does not entitle the bidder to claim any cost and rights over MMRDA and MMRDA shall be at liberty to cancel any or all bids without giving any notice.
- ii. All materials submitted by the bidder shall be the absolute property of MMRDA and no copyright /patent etc. shall be entertained by MMRDA.

#### 2.8 Bidder Inquiries

Bidder shall send in their written queries as prescribed in the **Section** Error! Reference source not found. **Page no. 80** to the contact address at which the bids are to be submitted. The response to the queries will be published on MMRDA website <a href="mailto:etendermmrda.maharashtra.gov.in">etendermmrda.maharashtra.gov.in</a> No telephonic/ e-mails queries will be entertained. This response of MMRDA shall become integral part of RFP document.

#### 2.9 Amendment of RFP Document

- i. All the amendments made in the document would be published at MMRDA website and shall be part of RFP.
- ii. The bidders are advised to visit the aforementioned website on regular basis for checking latest updates of this RFP document. The MMRDA also reserves the rights to amend the dates mentioned in this RFP for successful bid process.

#### 2.10 Supplemental Information to the RFP

If MMRDA deems it appropriate to revise any part of this RFP or to issue additional data to clarify an interpretation of provisions of this RFP, it may issue supplements to this RFP. Any such corrigendum shall be deemed to be incorporated by this reference into this RFP.

#### 2.11 MMRDA's right to terminate the process

MMRDA may terminate the RFP process at any time and without assigning any reason and MMRDA shall not be held responsible for any cost incurred by the bidder in bid preparation. MMRDA reserves the right to amend/edit/add delete any clause of this Bid Document. However this will be informed to all and will become part of the bid /RFP.

#### 2.12 Earnest Money Deposit (EMD)

The qualified bidders are requested to deposit the EMD into the Bank account details mentioned below. The receipt of the same shall be uploaded during the online submission of bid document.

- i. The EMD shall be denominated in Indian Rupees only. No interest will be payable to the bidder on the amount of the EMD.
- ii. Bids submitted without adequate EMD will be liable for rejection.
- iii. Unsuccessful bidder's EMD shall be returned to the unsuccessful bidder within 120 days from the date of opening of the financial bid.
- iv. EMD of Successful bidder will be returned after the award of contract and submission of the performance bank guarantee within specified time and in accordance with the format given in the RFP.
- v. EMD shall be non-transferable.
- vi. The EMD may be forfeited:
  - a) If a Bidder withdraws his bid or increases his quoted prices during the period of bid validity or its extended period, if any.

- b) If successful bidder fails to sign the Contract or to furnish Performance Bank Guarantee within specified time in accordance with the format given in the RFP.
- c) If during the bid process, a bidder indulges in any such deliberate act as would jeopardise or unnecessarily delay the process of bid evaluation and finalisation. The decision of the MMRDA regarding forfeiture of the Bid Security shall be final and binding upon bidders.
- d) If during the bid process, any information is found false/fraudulent/mala fide, then MMRDA shall reject the bid and, if necessary, initiate action.

#### 2.13 Language of Bids

This bid should be submitted in English language only. If any supporting documents submitted are in any language other than English/Hindi/Marathi, translation of the same in English language is to be duly attested by the bidder and summitted with the bid, and English translation shall be validated at MMRDA's discretion.

#### 2.14 Patent Claim

In the event of any claim asserted by a third party of infringement of copyright, patent, trademark or industrial design rights arising from the use of the Goods or any part thereof, the bidder shall expeditiously extinguish such claim. If the bidder fails to comply and MMRDA is required to pay compensation to a third party resulting from such infringement, the Bidder shall be responsible for such compensation, including all expenses, court costs and lawyer fees. MMRDA shall give notice to the successful bidder of any such claim and recover it from the bidder if required.

#### 2.15 Bid Submission Format

The entire proposal shall be submitted strictly as per the format specified in this Request for Proposal. Bids with deviation from this format are liable for rejection.

#### 2.16 Submission of Bids

The bids submitted by the Bidder shall comprise of the following three envelopes:

#### **Documents comprising the Bid**

- a) A Three envelope/ cover system shall be followed for the bid
  - i. Tender Fees, EMD and Pregualification Criteria
  - ii. Technical bid (including the credentials, technical proposal)
  - iii. Commercial bid.

c) The bidder should ensure that all the required documents, as mentioned in this RFP/bidding document, are submitted along with the bid and in the prescribed format only. Non-submission of the required documents or submission of the documents in a different format/contents may lead to the rejections of the bid proposal submitted by the bidder.

#### 2.17 Disqualification

The Proposal is liable to be disqualified in the following cases or in case the Bidder fails to meet the bidding requirements as indicated in this RFP:

- i. Proposal not submitted in accordance with the procedure and formats prescribed in this document or treated as non-conforming Proposal.
- ii. During validity of the Proposal, or its extended period, if any, the Bidder increases his quoted prices.
- iii. The Bidder qualifies the Proposal with his own conditions.
- iv. Proposal is received in incomplete form.
- v. Proposal is received after due date
- vi. Proposal is not accompanied by all the requisite documents.
- vii. Proposal is not accompanied by the EMD.
- viii. If the Bidder provides quotation only for a part of the Project.
- ix. Information submitted in Technical Proposal is found to be misrepresented, incorrect or false, accidentally, unwittingly or otherwise, at any time during the processing of the Contract (no matter at what stage) or during the tenure of the Contract including the extension period, if any
- x. Commercial Proposal is enclosed with the Technical Proposal.

- xi. Bidder tries to influence the Proposal evaluation process by unlawful/corrupt/fraudulent means at any point of time during the Bid process.
- xii. In case any one Bidder submits multiple Proposals or if common interests are found in two or more Bidders, the Bidders are likely to be disqualified, unless additional Proposals/Bidders are withdrawn upon notice immediately.
- xiii. Bidder fails to deposit the Performance Bank Guarantee (PBG) or fails to enter into a Contract within 15 Days of the date of issue of Letter of Intent or within such extended period, as may be specified by the MMRDA.
- xiv. Any Bid received by MMRDA after the deadline for submission of Bids shall be declared late and will be rejected, and returned unopened to the Bidder at the discretion of MMRDA. The validity of the bids submitted before deadline shall be till 180 days from the date of opening of the Financial Bid.
- xv. While evaluating the Proposals, if it comes to the MMRDA's knowledge expressly or implied, that some Bidders may have colluded in any manner whatsoever or otherwise joined to form an alliance resulting in delaying the processing of Proposal then the Bidders so involved are liable to be disqualified for this Contract as well as for a further period of three years from participation in any of the RFPs floated by the MMRDA.
- xvi. If the Bid Security Pre-qualification Proposal, Technical Proposal contain any information on price, pricing policy, pricing mechanism or any information indicative of the commercial aspects of the Bid.

#### 2.18 Bid Opening

- Envelope A containing EMD shall be opened initially in the presence of bidders and if the EMD is as per the criteria then Envelope B of the qualified bidders only shall be opened.
- ii. Envelope B containing the Technical Proposal shall be opened in the presence of the bidder/ representatives of bidder who choose to attend, at the address, date and time specified in the RFP.
- iii. Envelope C containing the Financial Proposal will remain unopened and will be held in custody of MMRDA until the time of opening of the Financial Proposals.
- iv. At the end of the evaluation of the Technical Proposals, MMRDA shall invite bidders who have qualified for the opening of the Financial Proposals. The date, time, and location of the opening of Financial Proposals will be informed by MMRDA separately and individually to qualified bidders.

#### 2.19 Evaluation Process

#### 2.19.1 Bid Evaluation Committee

i. The Bid Evaluation Committee constituted by the MMRDA shall evaluate the bids.

ii. The Bid Evaluation Committee shall evaluate the EMD (Envelope A), Technical bid (Envelope B) and Financial bids (Envelope C) and submit its recommendation to Competent Authority whose decision shall be final and binding upon the bidders.

#### 2.19.2 Pre-Qualification Criteria

The bidder shall fulfill all of the following eligibility criteria independently on date of submission of bid:

- i. The bidder must be a company registered under The Companies Act, 1956.
- ii. The bidder shall have minimum of **Rs.20 Cr** as average annual turnover from the turnover of the last five years.(Financial years,April 2009- March 2010, April 2011- March 2012 April 2012- March 2013 and April 2013- March 2014).
- iii. The bidder shall submit the Original Manufacturer Authorization Form duly signed and stamped by OEM for respective Hardware and Software component supplied under this scope of RFP.
- iv. The bidder shall have executed and completed work of **Rs 9 Cr** in the last three years (Financial years, April 2010-March 2011, April 2011- March 2012 and April 2012- March 2013). The work should include Supply, Installation and Commissioning of at least three from the below mentioned list (Order completion certificates from clients should be attached)
  - a. Desktop
  - b. Laptop
  - c. All in one Desktop
  - d. Printers
  - e. Scanner
  - f. Plotters
  - g. Projector
  - h. Apple Products
- v. The Bidder and OEM shall have Support Centre in Mumbai for Computer Hardware, Software and Peripherals.

#### 2.19.3 Process of Evaluation

- i. Bidders who qualify in Envelope 'A' shall be considered for further Technical evaluation.
- ii. Bidder shall be evaluated as per prequalification criteria mentioned above at 2.20.2. The bidders who fulfil all the prequalification criteria and are found technically responsive to the RFP requirements will qualify for Financial Evaluation.
- iii. Amongst the bidders who are considered for financial evaluation, the bidder quoting the lowest offer will preferably be awarded the work at the discretion of MMRDA.
- iv. The Bid Evaluation Committee reserves the right to accept or reject any or all bids without giving any reasons thereof.

#### 2.19.3.1 Technical Evaluation

Each Proposal which qualifies in Envelope A shall be scrutinized further technically for checking whether the offered Computer Hardware, software and Peripheral meets the RFP requirements along with technical specification. If bidder mentions any additional features against the hardware which is beyond the scope of this RFP shall not be considered at the time of bid evaluation stage. In case, the bid meets the RFP requirements and is found technically responsive then the bidder will qualify for further evaluation of Envelope C (Financial Bid). In case in MMRDA's opinion if there is a material deviation from the RFP requirement, it will treat the bid as non-responsive and may disqualify the bidder. The Envelope C of such disqualified bidder shall not be opened. MMRDA reserves the right to decide whether the deviation is material or not.

#### 2.19.4 Financial Bid Evaluation

MMRDA will evaluate Financial Proposals of all the qualified bidders. If there is a discrepancy between words and figures, the amount in words shall prevail. For any other calculation/summation error etc. the bid may be rejected.

#### 2.20 Award Criteria

MMRDA shall preferably award the contract to the technically qualified bidder who has quoted the least (Section 5.6 Page no. 41) subject to approval of competent authority at its discretion. The Bid Evaluation Committee, however, reserves the right to accept or reject any or all bids without giving any reasons thereof.

#### 2.21 Rate Contract

MMRDA reserves the right to enter into a rate contract with L1 bidder Supply, Installation and Commissioning of Computer Hardware, Software and Peripheral. The validity of the rate contract shall be 12 months from the completion and final acceptance date of commissioning of Computer Hardware, Software and Peripheral at MMRDA locations as mentioned in the first work order. The same technical specifications or higher capacity in case of non-availability of the hardware, software and terms of commercial bid shall apply to successful bidder to order placed through the rate contract as specified through this tender. However, during validity of the rate contract, if there is downward revision of the prices beyond 10% of the price negotiated at the time of placing the order, MMRDA reserve the right to re-negotiate the prices before placing the order.

#### 2.22 Signing of Contract

The successful bidder shall enter into contract agreement with MMRDA within the time frame mentioned in the award letter. The Draft Agreement format attached in (Section 6.3 Page no. 76)

#### 3 Scope of Work

MMRDA reserves the right to amend/add/delete/edit any of the following items of the scope of work at the cost of the bidder, which shall be binding on the successful bidder.

#### 3.1 Background

MMRDA has decided to implement e-Governance initiatives to improve its efficiency & effectiveness in service delivery. Below mentioned some of e-governance initiatives are being implemented in MMRDA.

Also, with above mentioned e-Governance initiatives, MMRDA have decided to equip its employees with state of art Computer Hardware, Software, Peripheral and discard the existing out dated IT Hardware inventory.

#### 3.2 Project Objective

The objective of this project is for provisioning, installing and commissioning of brand new and standard Computers Hardware, Software, Peripherals without any damage as per specified configuration in this tender throughout MMRDA office locations I.e. (Kalyan, Thane, CR2 Nariman Point, Wadala, and MMRDA old Building (BKC)) MMRDA also offers its existing old hardware by way of buy back offer. The bidder should analyse the IT hardware upgradation requirement and discuss the same with MMRDA. Subsequently, the bidder needs to submit the detailed installation and commissioning plan of the new IT hardware.

However, if the particular model becomes obsolete and such certificate is produced by the OEM with supporting document showing the replacement of the existing model with new model with higher specifications, the MMRDA may consider replacing the existing model with new model and the same will be published on the website as corrigendum. Purchase and Supply of product other than Make and Model mentioned in the tender / Corrigendum shall be construed beyond the purview of this tender.

The bidder must take care of below mentioned points while commissioning all above mentioned hardware but not limited to.

#### 3.2.1.1 Inter-working of Hardware and Software

The bidder shall integrate Computer hardware, software and peripheral components supplied by him to make the Computer system integrated and fully functional. It will be bidder's responsibility to locate the exact nature of the problem/faults and rectify the same.

The bidder must also take necessary steps to successfully install all the software components supplied by him on the hardware supplied. Moreover, any relevant software patches that are required to be applied, to the system software to make it compatible with supplied hardware must be identified and installed from time to time during warranty period.

#### 3.2.1.2 Data Transfer

The bidder should transfer all the data from old PC to respective new PC. Also, bidder shall uninstall all the applications/software except operating system in it.

#### 3.2.1.3 Software Drivers and Manuals

The bidder should supply software drivers and manuals for the Display controller, Ethernet interface, DVD-ROM drive, DAT Drive, SAS controllers, DVD-Writer and Operating system etc. as applicable. The bidder must provide genuine, legal, perpetual, full use licenses for Operating System pre-installed with all the desktops, AIO computers and other hardware supplied under scope of this RFP.

#### 3.2.1.4 Special Condition

#### 3.2.2 Hardware Warranty

The offer must include minimum of five years after sales service and 100 % comprehensive on-site warranty for all the hardware supplied under the scope of this RFP. After sales service and 100 % comprehensive on-site warranty would be start from single and uniform date. i.e. from the date of release of the acceptance document from MMRDA.

#### 3.2.3 Software Warranty

Bidder hereby grants MMRDA license to access all the softwares provided under the scope of this RFP, including all inventions, designs, and marks embodied in the Software. Comprehensive Onsite Warranty covering all updates, upgrades of software, maintenance or

support for its proper operation, performance and output as specified in the RFP technical specifications for a period of five Years from the Date of acceptance by the MMRDA.

#### 3.2.4 Hardware Failure

- i. The equipment/goods must conform to the specifications given and of desired quality standards. The bidder shall guarantee that the goods delivered to MMRDA is/are brand new and without any damages.
- ii. Consistency in delivery shall be maintained for the entire lot of products ordered. All the required quantity of equipment/s as per requirement shall be of the same brand and model number. The bidder shall not substitute any internal components or subsystems of the product by similar items of different manufacturer/s.
- iii. All the equipment shall be supplied with the relevant interface cables and necessary standard accessories. Also, all the equipment shall be provided with ISI standard, 3-pin power plugs (5-amp/15 amp, as required).
- iv. If during the warranty period, any equipment supplied under the scope of this RFP has a hardware failure on four or more occasions in a quarter, it shall be replaced by equivalent new equipment by the bidder at no cost to MMRDA.
- v. The bidder as well as the OEM shall be jointly and severally responsible for and quality of the supply.

#### 3.2.5 Technical Documentation

The Bidder shall submit the following documentation after installation of all equipments supplied under the scope of this RFP.

- a. Site diagram showing exact location supplied hardware.
- b. Bill of Material.
- c. Warranty certificate indicating 5 year's onsite warranty from the OEM for all the equipments supplied under the scope of this RFP.

#### 3.2.6 Acceptance Tests

At the discretion of MMRDA, acceptance test will be conducted by the bidder on installed Computer Hardware, Software and Peripheral at the MMRDA site in the presence of the officials of MMRDA. The tests will check for trouble-free operation of the complete system for ten consecutive days apart from physical verification and testing. There shall not be any additional charges payable by MMRDA for carrying out this acceptance test. MMRDA will take over the systems on successful completion of the acceptance test.

#### 3.2.7 Completeness of Installation & Commissioning

The installation and commissioning will be deemed as incomplete if any component of the hardware software etc. or any documentation/media is not delivered or is delivered but not installed and/or not operational or not acceptable to MMRDA after acceptance testing/examination. Also, the bidder shall have to supply all necessary accessories along with the supplied goods, appropriate licenses, device drivers, data sheets and documentation which may be required, whether mentioned or not mentioned in the RFP scope, for successful acceptance of the quoted equipment to MMRDA.

#### 3.2.8 Penalty Downtime

In the five year warranty period, any equipment supplied under this RFP scope that is reported to be down on given date should be repaired or replaced within 48 hours from the date and time of actual reporting.

In case bidder fails to meet the above standards of maintenance, there will be a penalty of Rs. 100 for each reported instance which does not meet the timelines mentioned above.

Ex. Three incidents were permissible time limits exceeded.

$$3 \times Rs.100 = Rs.300$$

The bidder would be liable to pay the penalty amount within a period of 15 days from the date of demand made by the MMRDA. If the bidder does not make the payment of penalty within the stipulated period, the MMRDA is free to invoke the bank guarantee and recover the amount. Penalty charges should be limited to the 10% of contract value till the end of contract period. However, MMRDA has right to blacklist the bidder on non-performance.

#### **3.2.9** Buy Back

It will be the responsibility of bidder to dispose whatever hardware quantity is left after selling it to MMRDA Staff. MMRDA will however reserve its right to withdraw / modify / retain some or all hardware at the time of actual delivery. The buyback offer will be valid for 30 days after the issuance of work order.

#### 4 General Conditions of Contract

#### 4.1 Governing Law

The Contract shall be governed by and interpreted in accordance with the laws of the India.

#### 4.2 Settlement of Disputes

a) Performance of the contract is governed by the terms and conditions of the contract, in case disputes arise between the parties regarding any matter under the contract, either Party of the contract may send a written Notice of Dispute to the other party. The Party receiving the Notice of Dispute will consider the Notice and respond to it in writing within 30 days after receipt. If that party fails to respond within 30 days, or the dispute cannot be amicably settled within 60 days following the response of that party, clause GCC 4.2 (b) shall become applicable.

#### b) Arbitration:

- (i) In the case of dispute arising, upon or in relation to, or in connection with the contract between MMRDA and the Successful bidder, which has not been settled amicably, any party can refer the dispute for Arbitration under (Indian) Arbitration and Conciliation Act, 1996. Such disputes shall be referred to an Arbitral Tribunal consisting of three arbitrators, one each to be appointed by the MMRDA and the successful bidder, the third arbitrator shall be chosen by the two arbitrators so appointed by the parties and shall act as Presiding Arbitrator. In case of failure of the two arbitrators, appointed by the parties to reach a consensus regarding the appointment of the third arbitrator within a period of 30 days from the date of appointment of the two arbitrators, the Presiding arbitrator shall be appointed by the MC, MMRDA. The Arbitration and Conciliation Act, 1996 and any statutory modification or re-enactment thereof, shall apply to these arbitration proceedings.
- (ii) Arbitration proceedings shall be held in Mumbai, India and the language of the arbitration proceedings and that of all documents and communications between the parties shall be English.
- (iii) The decision of the majority of arbitrators shall be final and binding upon both parties. The expenses of the arbitrators as determined by the arbitrators shall be shared equally by MMRDA and the successful bidder. However, the expenses incurred by each party in connection to the preparation, presentation shall be borne by the party itself. All arbitration awards shall be in writing and shall state the reasons for the award.

#### 4.3 Taxes and Duties

The successful bidder shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed The bidder shall be entirely responsible for all taxes, stamp duties, license fees etc excluding service tax which shall be paid by MMRDA as applicable separately.

#### 4.4 Performance Bank Guarantee

- i. The successful bidder shall at his own expense, deposit with MMRDA, within fourteen (14) working days of the date of notice of award of the contract or prior to signing of the contract, whichever is earlier, an unconditional and irrevocable Performance Bank Guarantee (PBG) from a Nationalised bank acceptable to MMRDA, payable on demand (In Mumbai), for the due performance and fulfilment of the contract by the successful bidder. Please Refer (Section 6.3 Page no.76)
- ii. This Performance Bank Guarantee will be for an amount equivalent to 9 percent of complete contract value for 5 years. All charges whatsoever such as premium, commission, etc., with respect to the Performance Bank Guarantee shall be borne by the successful bidder.
- iii. The Performance Bank Guarantee shall be valid till the end of six months after the Supply, Installation and Commissioning of Computer Hardware, Software and Peripheral various MMRDA locations and Buy Back of out dated Hardware Inventory and should be in the format prescribed in the tender.
- iv. The Performance Bank Guarantee may be discharged/returned by MMRDA upon being satisfied that there has been due performance of the obligations of the successful bidder under the contract. However, no interest shall be payable on the Performance Bank Guarantee.
- v. MMRDA shall also be entitled to make recoveries from the Bidder's bills, performance bank guarantee, or from any other amount due to him, the equivalent value of any payment made to him due to inadvertence, error, collusion, misconstruction or misstatement.

#### 4.5 Confidential Information

MMRDA and the successful bidder shall keep confidential and shall not, without the written consent of the other party hereto, divulge to any third party any documents, data, or other information furnished directly or indirectly by the other party hereto in connection with the Contract, whether such information has been furnished prior to, during or following completion or termination of the Contract.

MMRDA shall not use such documents, data, and other information received from the successful bidder for any purposes unrelated to the Contract. Similarly, the successful bidder shall not use such documents, data, and other information received from MMRDA for any

purpose other than the design, procurement, or other work and services required for the performance of the Contract.

#### 4.6 Warranty

All the supplied goods are new, unused, and of the most recent or current models, and that they incorporate all recent improvements in design and materials, unless provided otherwise in the Contract.

The goods shall be free from defects arising from any act or omission of the successful bidder or arising from design, materials, and workmanship, under normal use in the conditions prevailing in the country of final destination.

#### 4.7 Change in Laws and Regulations

Unless otherwise specified in the Contract, if after the date of the Invitation for Bids, any law, regulation, ordinance, order or bylaw having the force of law is enacted, promulgated, abrogated, or changed that subsequently affects the Delivery Date and/or the Contract Price, then such Delivery Date and/or Contract Price shall be correspondingly increased or decreased, to the extent that the successful Bidder has thereby been affected in the performance of any of its obligations under the Contract.

#### 4.8 Force Majeure

The successful bidder shall not be liable for forfeiture of its Performance Security, liquidated damages, or termination for default if and to the extent that it's delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure. Force Majeure shall not cover the price fluctuation of components.

For purposes of this Clause, Force Majeure means an event or situation beyond the control of the successful bidder that is not foreseeable, is unavoidable, and its origin is not due to negligence or lack of care on the part of the successful bidder. Such events may include, but not be limited to, acts of MMRDA in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions, and freight embargoes.

If a Force Majeure situation arises, the successful Bidder shall promptly notify MMRDA in writing of such condition and the cause thereof. Unless otherwise directed by MMRDA in writing, the successful Bidder shall continue to perform its obligations under the Contract as far as it is reasonably practical and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.

#### 4.9 Change Orders and Contract Amendments

MMRDA may at any time order the successful bidder to make changes within the general scope of the Contract, in any one or more of the following:

i. Drawings, designs, or specifications, where Goods to be furnished under the Contract are to be specifically manufactured for MMRDA.

- ii. The place of delivery.
- iii. The Related Services to be provided by the successful bidder.

If any such change causes an increase or decrease in the cost of, or the time required for, the successful bidder's performance of any provisions under the Contract, an equitable adjustment shall be made in the Contract Price or in the Delivery and Completion Schedule, or both, and the Contract shall accordingly be amended. Any claims by the successful bidder for adjustment under this Clause must be asserted within 28 days from the date of the successful bidder's receipt of MMRDA's change order.

Prices to be charged by the successful bidder for any Related Services that might be needed but which were not included in the Contract shall be agreed upon in advance by the parties, and shall not exceed the prevailing rates charged to other parties by the successful Bidder for similar services.

#### 4.10 Extension of Time

If at any time during performance of the Contract, the successful bidder encounter conditions impeding timely delivery of the Goods or completion of Related Services, the successful bidder shall promptly notify MMRDA in writing of the delay, its likely duration, and its cause. As soon as practicable after receipt of the successful bidder's notice, MMRDA shall evaluate the situation and may at its discretion extend the successful bidder's time for performance in writing.

Delay by the successful Bidder in the performance of its Delivery and Completion obligations shall render the Bidder liable for disqualification for any further bids in MMRDA, unless an extension of time is agreed mutually.

#### 4.11 Termination

#### 4.11.1 Termination by MMRDA

- a. MMRDA may, without prejudice to any other remedy for breach of Contract, terminate this Contract in case of the occurrence of any of the events specified in paragraphs (a) through (k) of this GCC Clause 4.11.1. In such an occurrence, MMRDA shall give a not less than 30 days' written notice of termination to the successful bidder, and sixty (60) days' in the case of the event referred to in (j).
- b. If the successful bidder does not remedy a failure in the performance of their obligations under the Contract, within thirty (30) days after being notified or within any further period as MMRDA may have subsequently approved in writing.
- c. If the successful bidder becomes (insolvent or goes into liquidation, or receivership whether compulsory or voluntary.
- d. If the successful bidder, in the judgment of MMRDA has engaged in corrupt or fraudulent practices in competing for or in executing the Contract.
- e. If the successful bidder submits to the MMRDA a false statement which has a material effect on the rights, obligations or interests of MMRDA.

- f. If the successful bidder places itself in a position of conflict of interest or fails to disclose promptly any conflict of interest to MMRDA.
- g. If the successful bidder fails to provide the quality services as envisaged under this Contract, MMRDA may make judgment regarding the poor quality of services, the reasons for which shall be recorded in writing. MMRDA may decide to give one chance to the successful Bidder to improve the quality of the services.
- h. If the successful bidder fails to comply with any final decision reached as a result of arbitration proceedings.
- i. If, as the result of Force Majeure, the successful bidder is unable to perform a material portion of the Services for a period of not less than 60 days
- j. If MMRDA, in its sole discretion and for any reason whatsoever, decides to terminate this Contract.
- k. In the event MMRDA terminates the Contract in whole or in part, pursuant to point (a) to (h) of GCC Clause 4.11.1, MMRDA may procure, upon such terms and in such manner as it deems appropriate, services similar to those undelivered or not performed, and the successful bidder shall be liable to MMRDA for any additional costs for such similar services. However, the successful bidder shall continue performance of the Contract to the extent not terminated.

#### 4.11.2 Termination by Bidder

The successful bidder may terminate this Contract, by not less than 30 days' written notice to MMRDA, such notice to be given after the occurrence of any of the events specified in paragraphs (a) through (d) of this GCC Clause 4.11.2:

- a. If MMRDA fails to pay any money due to the Successful bidder pursuant to this Contract and not subject to dispute pursuant to GCC Clause 5.2 hereof, within 45 days after receiving written notice from the successful bidder that such payment is overdue.
- b. If, as the result of Force Majeure, the successful bidder is unable to perform a material portion of the Services for a period of not less than 60 days.
- c. If MMRDA fails to comply with any final decision reached as a result of arbitration pursuant to GCC Clause 4.2 hereof.
- d. If MMRDA is in material breach of its obligations pursuant to this Contract and has not remedied the same within 45 days (or such longer period as the successful bidder may have subsequently approved in writing) following the receipt by MMRDA of the Successful bidder's notice specifying such breach.

#### 4.12 Payment upon Termination

Upon termination of this Contract pursuant to GCC Clauses 4.11.1 or 4.11.2, the MMRDA shall make the following payments to the Successful bidder:

a. If the Contract is terminated pursuant to GCC Clause 4.11.1 (j) or 4.11.2, remuneration for Services satisfactorily performed prior to the effective date of termination.

b. If the agreement is terminated pursuant of GCC Clause 4.11.1 (a), (b), (c), (d), (e), (f), (g) (h) and (k), The successful bidder shall not be entitled to receive any agreed payments upon termination of the contract. However, the MMRDA may consider making a payment for the part satisfactorily performed on the basis of Quantum Merit as assessed by it, if such part is of economic utility to the MMRDA. Applicable under such circumstances, upon termination, the MMRDA may also impose liquidated damages. The successful bidder will be required to pay any such liquidated damages to MMRDA within 30 days of termination date.

#### 4.13 Applicable laws

- The Contract shall be interpreted in accordance with the laws prevalent in India.
- ii. Compliance with all applicable laws: The Bidder shall undertake to observe, adhere to, abide by, comply with and notify the Department about all laws in force or as are or as made applicable in future, pertaining to or applicable to them, their business, their employees or their obligations towards them and all purposes of this Tender and shall indemnify, keep indemnified, hold harmless, defend and protect the Department and its employees/ officers/ staff/ personnel/representatives/ agents from any failure or omission on its part to do so and against all claims or demands of liability and all consequences that may occur or arise for any default or failure on its part to conform or comply with the above and all other statutory obligations arising there from.
- iii. Compliance in obtaining approvals/ permissions/ licenses: The Bidder shall promptly and timely obtain all such consents, permissions, approvals, licenses, etc., as may be necessary or required for any of the purposes of this project or for the conduct of their own business under any applicable Law, Government Regulation/Guidelines and shall keep the same valid and in force during the term of the project, and in the event of any failure or omission to do so, shall indemnify, keep indemnified, hold harmless, defend, protect and fully compensate the Department and its employees/ officers/ staff/ personnel/ representatives/agents from and against all claims or demands of liability and all consequences that may occur or arise for any default or failure on its part to conform or comply with the above and all other statutory obligations arising there from and the Department will give notice of any such claim or demand of liability within reasonable time to the bidder.
- iv. All legal disputes are subject to the jurisdiction of Civil Courts Mumbai only.

#### 4.14 Assignment

Neither the MMRDA nor the successful Bidder shall assign, in whole or in part, their obligations under this Contract, except with prior written consent of the other party.


