Interested Bidders have to make payment of Rs. 20,000.00 (Rupees Twenty Thousand only) inclusive of MVAT (non refundable) as Tender Processing Fees by mode of Electronic transfer. 7. The competent authority reserves the right to reject any or all of the tender offers, without assigning any reason thereof.
8. The tenders shall be received online on above mentioned MMRDA official E-Tendering portal.
9. Validity period of the offer of the tenderer will be 120 days from the date of opening of the financial bid of the e-tender.
10. The bidder in its name should meet the following eligibility criteria in the last 3 financial years i.e. 2011-12 to 2013-14 (i.e.01/04/2011 to 31/03/2014).
 - a) Achieved in at least two financial years minimum annual financial turnover (in all classes of civil construction works only) not less than estimated amount put to tender as shown in column no.3.
 - b) The firm shall have satisfactorily completed as a prime contractor at least one similar work i.e. for:--
 - i) Construction of Retaining wall by Rotary Touch piling method with minimum 200 no. of piles of 1000mm dia. and above with permanent M.S.liners as single work during last 3 financial years.
 - ii) The total aggregate value of the civil works shall not be less than 80% as a single work in last 3 financial years i.e. 2011-12 to 2013-14 (i.e.01/04/2011 to 31/03/2014).
 - c) Contactor has to submit documentary proof regarding ownership/undertaking on legal stamp paper about arrangements of sufficient number of Rotary Drilling Machine (Minimum 2 Nos.) for 1000mm dia. and above piling work and for Concrete Batching Plant (RMC).
11. A statement showing names of Partners, Directors etc. of the firm with complete address of each should be uploaded to above mentioned MMRDA official E-Tendering portal and authorized person on behalf of firm should sign e-tender using digital signature certificate.

12. The acceptance of tender will be intimated by email or otherwise by the authority competent to accept the tender or by the higher Authority of MMRDA, to the contractor, which shall be deemed to be an intimation of the tender given by the Authority Competent to accept the tender.
13. The lowest tenderer shall be equally responsible for executing, completing the work as per contract conditions and if any decision of consumer/any Hon. Court is received regarding quality of work then the judicial decision will be binding on the contractor for rectification.
14. Awarded tenderer shall have to submit signed copy of tender manually to the department.
15. MMRDA reserves the right to verify financial transaction of contractor in his Bank / Financial Institutions. Contractor should give authority to that effect along with his accounts number and Bank/ Financial institution name & address. Any changes / modification may be communicated to MMRDA immediately.
