 - c) Average annual turnover during the recent last 3 financial years shall be 100% of cost put to tender.
- d)The intending tenderers should also produce Solvency Certificate to the tune of 20% of the cost put to tender for the work.

- 4) Any type of influence during the process of tendering shall disqualify the tender from submission of his offer and further processing of his offer.
