- 15. The contractor should have executed at least one work of same magnitude and nature in last two financial years.
- 16. Bidder should upload scanned attested photocopies of all documents on above mentioned MMRDA official E-Tendering portal & produce in original on request by MMRDA at any stage from e-Tender opening.

- 18. The acceptance of tender will be intimated by email or otherwise by the authority competent to accept the tender or by the higher Authority of MMRDA, to the contractor, which shall be deemed to be an intimation of the tender given by the Authority Competent to accept the tender.
